CONTRACT TITLE: Supply of Equipment for the Implementation of the Project – EU Support to REDI Phase II: Advancing Roma Entrepreneurs in the Western Balkans and Turkiye

Article 1 Subject

- 2.1 The subject of the contract shall be the supply of the following supplies:
Nine Laptops, Six Mobile Phones, and One Network Office Printer, divided into two (2) lots.
- Lot n° 1: Nine Laptops (Four for the Project Staff and Five for the Business Centre Team) and Six Mobile Phones (Three for the Project Staff and Three for the Business Centre Team);
- Lot n° 2: One Network Office Printer.
- The place of acceptance of the supplies shall be Belgrade, Serbia, and the time limits for delivery shall be a maximum of 60 days from the publication of the tender, and the Incoterm applicable shall

be DDP⁴. The implementation period of tasks shall run for 30 days from the date of receiving the award notification.

- 1.2 The contractor shall comply strictly with the terms of the special conditions and the technical annex.
- 1.3 The supplies which form the subject of Lots No. 1 and 2 must be accompanied by the spare parts described by the contractor in its tender and by the accessories and other items necessary for using the goods over a period of two years, as specified in the instructions to tenderers.

Article 2 Origin

The rules of origin of the goods are defined in Article 10 of the special conditions.

When required, a certificate of origin for the goods must be provided by the contractor at the latest when it requests provisional acceptance of the goods. Failure to comply with this condition may result in the termination of the contract and/or suspension of payment.

Article 3 Price

- 3.1 The price of the supplies shall be that shown on the financial offer (specimen in Annex IV).

The total maximum contract price shall be a maximum EUR 13,725 for LOT1 and EUR 2,800 for LOT 2.

- 3.2 Payments shall be made in accordance with the general and/or special conditions (Articles 26 to 28).

Article 4 Order of precedence of contract documents

The contract is made up of the following documents, in order of precedence:

- The contract agreement;
- The special conditions
- The general conditions (Annex I);
- The technical specifications (Annex II, including clarifications before the deadline for submission of tenders);
- The technical offer (Annex III, including clarifications from the tenderer provided during tender evaluation);
- The budget breakdown (Annex IV);
- Forms (Financial Identification Form and Legal Entity File)

The various documents making up the contract shall be deemed to be mutually explanatory; in cases of ambiguity or divergence, they shall prevail in the order in which they appear above.

Article 5 Other specific conditions applying to the contract

For the purpose of Article 44 of the general conditions, for the part of the data transferred by the contracting authority to the European Commission:

(a) The controller for the processing of personal data carried out within the Commission is the head of the contracts and finance unit R4 of DG Neighbourhood and Enlargement Negotiations.
